Terms and conditions for amateur fishing and instructions for filling in “The Catch Register”

1. Before starting any fishing, an angler is obliged to fill in the fields: "Date of fishing" and "Fishing ground number". (Numbering of the fishing grounds: for lowland rivers from 1-12, for dam reservoirs 13-19, for mountain waters 21-32, numbering for still waters from 0.2 to 0.133).
2. After catching fish covered by the quantitative limit in pieces /see table/ and after putting them into the net, immediately enter **each species in a separate row in the table and mark each caught piece with a vertical line**. Fill in the "Length of fish" field after the fishing has finished.
NOTE! Species such as: zander, pike are to be entered in a separate table immediately after catching, along with their dimensions and the time they were caught.
3. In the case of not taking caught fish from the fishery, immediately after catching release them into the water without recording them in the register.
4. Special rules apply to the official training before the sports competition organised by the District. In this case, the word "training" must be entered next to the fishing area number and the fishing date.
5. When fishing in the waters of circuits that are not the main waters: e.g. fishing on the Ścinawka river, enter No. 7c in the register.
6. The register must be returned to the relevant fishing club at the end of the season. In the event of completing the entire register before the end of the season, anglers are obliged to continue the entries on the additional insert, which they can obtain from their club.
7. Fish species that are not listed in the table are not to be entered in the register.

8. Fill in the register with a pen, **do not divide the rows in the catch register**.
9. It is forbidden to use erasable writing materials, concealers, as well as to remove, delete, correct entries in the catch register. The finding of such acts by the control services will result in immediate detention of the above-mentioned document and referral of the application to the competent authorities as deprived of the feature of reliability and credibility as a result of unauthorised modifications of its provisions. In the event of a mistake, make a correct entry in the next field and initial the corrected entry.

Registration of catches makes it possible to assess the fishing pressure on individual waters, which enables sustainable management of fisheries .

*On the Nysa Klodzka river section from the Kozielno reservoir dam to the Nysa reservoir dam there are no limits, but the register must be filled in.

Additional information

Logging fish catches is the responsibility of each member of the PZW (Polish Angling Association) and is obligatory for all fishing grounds of the Opole District. According to the resolution of the Presidium of ZO No. 73/Presidium/2006 of 18/12/2006 "any member of the District of PZW Opole who fails to comply with the obligation to timely submit the catch register for the current year is subject to a penalty fee of PLN 30."

Regulations of the Opole Voivode No. 0151/P/1/04, 0151/P/3/05, 0151/P/7/2004, Decision No. 170/2008 of the Management Board of the Opole Voivodeship and Resolution No. 4886/2010, No. 3211/2017 established protective areas including:

- the Nysa Kłodzka River - the section of 300 m below the discharge structure of Kozielno reservoir;
- the Nysa Kłodzka River in Otmuchów - the section of 100 m below the weir of the Otmuchów retention reservoir power plant;
- the Mała Panew river in Turawa - the section of 200 m below the weir of the power plant at Turawa retention reservoir;
- the South-East of Śródlesie II in the city of Opole;
- the waters of the Widawa River, its tributaries, floodplains, drainage ditch waters and the Michalice Reservoir waters within a radius of 100 m from the bridge over the tributary to the Michalice Reservoir;
- the river Nysa Kłodzka in Nysa - the section of 200 m below the dam of the Nysa retention reservoir;
- the Nysa Kłodzka River in Nysa - the section of 100 m below and above the weir at ul. Wyspiańskiego;
- the Nysa Kłodzka River in Nysa, the section from the weir of the power plant at ul. Szlak

Chrobrego to the Bema bridge;

- the Nysa Kłodzka River in Nysa - the section of 100 m below the weir at Aleja Wojska Polskiego;

Resolution 4886/2010 of the Management Board of the Opole Voivodeship established temporary protective areas in force from March 1 to May 31 of each year: on the Turawa Reservoir covering the south-eastern part of the Turawa reservoir from the promontory known locally as "Angel Spitz", including the mouth of the Libawa River, Mała Panew and the pumping station to the promontory at the height of Szczedrzyk;

- on the Mała Panew river - covering the section from the bridge in Czarnowąsy to the point where Mała Panew river flows into the Odra;
- on the Nysa Reservoir - the section from the information board at the end of the embankment in Siestrzechowice to the information board in Buków;
- on the Otmuchów Reservoir - the section from the excavated railway track in the town of Ligota to the mouth of the Nysa Kłodzka River;
- on the oxbow lakes of the Odra River in the village of Rogi.

Fish wintering grounds have been established, where fishing is prohibited from 1 January to 31 March and from 1 December to 31 December:

- The canal of the Odra river in Zwanowice on the section of 300m below the lock,
- The canal of the Odra river in Brzeg - the section of 200 meters below the lock,
- The canal of the Odra river in Brzeg under the bridge at ul. Krakusa (road no. 39), a section of 100 meters below and above the bridge,
- The Port Canal (Kanał Portowy) in Opole on the Odra River,
- The NEW SIOŁKOWICE quarry 0.50 in accordance with the info boards,
- The Odra river in Krapkowice, port "MARINA",

- "WYRWA" on the Odra river in the town of Krapkowice - a bay created as a result of flooding in 1997 (next to the railway bridge),
- On the oxbow lakes of the Kłodnica river in Kędzierzyn-Koźle (Kędzierzyn district) - the section from the culvert under the bypass to the mouth of the Kłodnica river (info boards).
- The Nysa Kłodzka river in Lewin Brzeski - the section from the new weir to the bridge on the Lewin Brzeski - Niemodlin road.
- On the oxbow lakes of the Nysa Kłodzka river - the section below the bridge on road 46 between the towns of Malerzowice Wielkie and Sidzina (the area known as "Portki").

Fish spawning grounds have been established, where fishing is prohibited from 1 March to 15 June:

- The Turawa reservoir - the bays near the "Syrenka" and "Relax" holiday resorts (overview map: <https://2833.pzw.org.pl/cms/25737/mapy>)
- The Dębowa reservoir - the "Meliorant" bay
- The Przysiecz Reservoir - spawning grounds marked with information boards (map)
- The Nysa Kłodzka river - 1000 m above the temporary protective area on the Otmuchów Reservoir upstream of the river (information boards)
- the Nysa Kłodzka river - from the remains of the pillars of the bridge in Wójcice to the road bridge on "Otmuchów bypass," including floodplains.

A ban on fishing from the islands in the Nysa Reservoir is in force from 1 March to 15 June.

Extension of the ban on fishing in temporary protection areas on the Nysa, Otmuchów, Turawa dam reservoirs until 15 June.

Fishing in parts of the Przysiecz zone is prohibited as per information boards (map).

On the Kluczbork Reservoir, fishing on the Stobrawa River is prohibited - 50 meters above the initial reservoir, on the initial reservoir, and within a radius of 50 meters below the outlet of the initial reservoir, as well as on the Stobrawa River up to the wooden bridge below the Kluczbork reservoir

(as per information boards). It is forbidden to fish from the islands in the Kluczbork Reservoir. On the Nysa Kłodzka river in Lewin Brzeski, fishing near the new weir at 13+845 km (within protective barriers) is prohibited and marked with info boards.

On the dam reservoirs of Turawa, Nysa, Otmuchów, fishing is prohibited at power plants, covering a section of 100 m from the water storing dam (marked with a line on the embankment and buoys).

On the Odra river, fishing is allowed 100 meters away from weirs and locks and is prohibited in Brzeg on Kępa Młyńska below the water barrage.

On Kanał Ulgi in Opole, it is forbidden to fish within 100 meters from weirs and locks.

On the Odra River from the mouth of the Gliwice Canal from the km 98.100 board to the 99.300 km board - prohibition to take or keep caught fish. The "CATCH and RELEASE" section does not apply to fishing competitions.

On Biała Głucholaska river, it is forbidden to practise amateur fishing on the section between the footbridge in Głucholazy Zdrój and the dam at the stadium in Głucholazy.

On Biała Głucholaska river it is forbidden to practise amateur fishing on the section between Small Hydroelectric Power Plant at the "Skowronek" resort and the footbridge in Głucholazy Zdrój during the spawning season, i.e. from 1 March to 31 May.

General terms and conditions of fishing are set out in the Regulations of Amateur Fishing

The provisions of the Regulations shall apply to all anglers (both members of the Association, as well as non-associated Polish citizens and foreigners) fishing in the waters used by the Polish Angling Association in Opole.

II. THE RIGHTS OF ANGLERS FISHING IN PZW WATERS

1. The right to fish in the waters used by the Polish Angling Association is vested in the members of the Polish Angling Association and persons not affiliated with the Polish Angling Association who possess a fishing licence and foreigners who comply with the rules included in these Regulations and the permit obtained from the authorised person for

fishing.

2. The rules for issuing fishing licences are governed by the provisions of the Act of 18 April 1985 on Inland Fisheries, as amended.
3. Persons up to 14 years of age and foreigners temporarily residing in Poland are exempt from the obligation to have a fishing licence.
4. An angler who is over 14 years of age has the right to fish independently, but young people up to 16 years of age do not have the right to fish at night without the supervision of an adult.
5. A member of PZW under the age of 14 has the right to fish within its own fishery in accordance with the applicable fish conservation dimensions, quantitative and weight limits, with the following restrictions:
 - without the right to use live or dead fish as bait;
 - only under the care of an adult with a fishing licence who is responsible for the compliance with the provisions of the RAPR, the rules laid down by the fishing authoriser and the rules of fishing ethics;
 - fishing must be carried out with continuous and direct supervision of the fishing rods;
 - the right to fish for a member of PZW for up to 7 years of age, is limited to one fishing rod, while all other above-mentioned regulations apply.
6. A non-PZW member, up to the age of 14, has the right to fish only under the care of an adult, holding a fishing licence and a fishing permit, within the scope of their rights, rules of the fishing grounds and daily catch limit, without the right to fish with the use of a live or dead fish as bait. The person exercising custody during fishing is responsible for compliance by the above-mentioned non-associated underage person with all regulations in force in a given fishery. The right to fish for a non-member of PZW for up to 7 years of

- age, is limited to one fishing rod, while all other above-mentioned regulations apply.
- Two people up to 14 years of age listed in point 6 for each rod can fish under the care of a fishing licence holder. This does not apply to waters within the land of trout and grayling. Making the fishing spot and limit available to the two persons mentioned in point 6 excludes fishing by the guardian. In the case of supervising only one underage person, fishing is allowed to the guardian who can use one fishing rod.
 - Organised groups of young people up to the age of 14, including those not affiliated to PZW, are allowed to fish during training and fishing competitions, under the supervision of a supervisor with appropriate instructor or inspector qualifications issued by PZW, under the conditions specified by an authorised person. Each member of the group shall have the right to use one fishing rod, their own fishing spot and the same daily catch limit as allowed to a PZW member.

III. OBLIGATIONS OF ANGLERS FISHING IN PZW WATERS

- When choosing and occupying a fishing spot in the fishery, priority shall be given on a come first serve first basis. When taking up their posts, anglers shall keep the appropriate spacing between them as laid down in Chapter V of the Terms and Conditions. The distance between posts may be reduced only with the consent of the angler who arrived at a given spot first.
- During fishing, the fishing rods must be under the constant supervision of their users.
- Anglers are obliged to use an instrument for removing hooks from the fish's mouth. Fish should be released from the hook with the utmost caution.

IV. FISHING RULES

1. Fishing rod

The angler is obliged to use a fishing rod consisting of a rod which is at least 30 cm long, to

which a fishing line is attached with:

- a. one hook with bait , or
- b. in the fly method, no more than two hooks, each with an artificial bait, and each hook may have no more than two blades spaced apart so that they do not extend beyond the circumference of a 30 mm diameter wheel, or
- c. in the spinning and trolling method, an artificial bait equipped with no more than two hooks; the hook may have no more than four blades spaced so that they do not extend beyond the circumference of a 30 mm diameter wheel.
- d. for ice fishing:
 - one bait hook, the hook not having more than three blades spaced so as not to extend beyond the circumference of a 20 mm diameter wheel, or
 - artificial bait fitted with no more than two hooks, each hook having no more than three blades spaced so as not to extend beyond the circumference of a 20 mm diameter wheel.

2. Baits

a. Permissible baits include:

- natural baits: animal and plant based,
- artificial baits.

b. It is forbidden to use as bait (lure):

- protected species of animals and plants, spawn

c. Natural animal baits are living or dead organisms, as well as their parts. In the case of using fish as bait, only dimensional fish or fish not covered by the protective dimension

and not during the protective period may be used.

- d. Natural plant baits are plants, their parts and products made from plants (e.g. cakes and pastes) as well as cheese.
- e. Artificial baits are a group of baits made of various natural or artificial materials. These baits may be armed with a maximum of two hooks with a blade spacing of not more than the width of the bait (with a tolerance of up to 2 mm).

3. Fishing

3.1. In the waters used by PZW, you can fish around the clock, except for the waters of the land of trout and grayling where you are allowed to fish only from dawn to dusk, i.e. 1 hour before sunrise and 1 hour after sunset.

3.2. It is prohibited to fish during the protection periods and in designated conservation areas, such as spawning grounds, breeding sets, wintering grounds, nurseries. It is prohibited to fish within the protection and farming areas.

3.3. Anglers are obliged to comply with the limits of daily fishing.

3.4. In addition, they must not:

- a. store and collect fish below or above their protective dimensions,
- b. sell the fish caught,
- c. give caught fish to others in the area of the fishery,
- d. fish at a distance of less than 50m away from: weirs, locks, dams and other structures used for damming water. This prohibition does not apply to hydrotechnical structures used to regulate the banks or bottom of bodies of water, e.g. groynes, breakwaters and bottom thresholds,

- e. fish less than 50m away from set and marked nets and other fishing gear,
- f. fish using the "jerkbait" method - by deliberately harvesting fish by undercutting in order to hook the fish.
- g. build fishing platforms and stands without the consent of the water user,
- h. use artificial light to locate or lure fish,
- i. fish from bridges,
- j. cut off the heads and tails of the fish before completing fishing.

3.5. Caught fish (except salmonids) may be kept alive in nets made of soft thread, spread over rigid rims or in specialised carp bags. The amount of fish stored in the nets cannot be higher than the amount established by daily limits.

- a. salmonids to be taken must be killed immediately after catching,
- b. each angler must keep fish they catch separately.

3.6. Catches of undersized or protected fish must be promptly released into the water with caution.

3.7. Spinycheek crayfish, signal crayfish and fish of the Chinese sleeper species, round goby, stone moroko and bullpout after catching must not be released into the fishery where they were caught or into other waters.

3.8. When fishing to obtain fish for bait, simultaneous fishing by spinning and fly fishing is prohibited.

3.9. It is allowed, at the place and time of fishing with a fishing rod, to fish for bait using a hand net. The net area of the fishing net should be not more than 1 m x 1 m and the mesh size should not be less than 5 mm.

- 3.10. Fish intended for bait may only be released into the waters from which they were taken, with the exception of the species listed in point 3.7. Fish intended for bait, in the live state, may be kept in a container or in a net in a way ensuring their well-being.
- 3.11. Cross lining of the riverbed for the so-called fishing over the water surface (trotline / dropline fishing) is prohibited; the act constitutes an offence under art. 160 § 1. of the Criminal Code.

V. PERMITTED FISHING METHODS

1. Ground and float fishing

1.1. Fishing using the ground and float method is allowed for two rods at the same time, each with a line ending with one hook with natural bait.

1.2. An angler using this method is obliged to maintain the following minimum distances from other anglers: **a)** fishing from the shore - 10 m /**b)** between boats or wading - 25 m /**c)** between the boat and other anglers fishing from the shore - 50 m.

2. Spinning method

2.1. Fishing by spinning is allowed with one rod, which must be held by hand, with a line ending in one artificial bait, armed with no more than two hooks. During spinning, using any additional bait indicators installed on the line is not permitted.

2.2. An angler fishing with this method is obliged to maintain the following minimum distances from other anglers:

a) fishing from the shore or wading - 25 m /**b)** fishing from a boat - 50 m.

3. Trolling method

3.1. Trolling is only allowed for one fishing rod, ending with a line with one artificial bait, armed with no more than two hooks, towed behind a vessel powered by engine, sails or the

strength of human muscles. It is forbidden to tow natural baits this way.

3.2. When fishing with this method, it is obligatory to maintain a minimum distance of 50 m from other anglers.

3.3 Prohibition of trolling in all waters. It does not apply to the Odra River.

4. Fly Fishing

4.1. Fly fishing is permitted with one hand-held fishing rod, equipped with a centerpin and a fly line with no more than two hooks, each with an artificial lure - each hook not having more than two blades spaced in such a way that they do not extend beyond the circumference of a circle of 30 mm in diameter.

Lines other than fly line in this method may only be used to bind clips, the length of which, must not exceed twice the length of the rod used and as a backing for the fly line. It is forbidden to use any additional external load or a leader and it is forbidden to use hydro pods or any other objects in their place (indicators, bait indicators).

4.2. When using this method, it is obligatory to maintain minimum distances from other anglers:

a) from the shore or wading - 25 m.

5. Ice fishing

5.1. Ice fishing using artificial bait - other than mormyshka - is allowed with one fishing rod, and in the case of natural bait or mormyshka with two fishing rods. A mormyshka is a bait in the form of a uniform body, of any shape and colour, with a length of not more than 15 mm, with a fused or soldered single-blade hook.

5.2. Holes in ice should be made with a diameter of not more than 20 cm, and the distance between two holes should not be smaller than 1 m.

5.3. It is forbidden to fish at night, i.e. from dusk to dawn.

5.4. Fish to be taken must be killed immediately after catching. Slaughtered fish should be stored in containers.

5.5. When fishing with this method, an angler is obliged to maintain a minimum distance of 10 m from other anglers.

5.6. It is forbidden to use dead and live fish as bait.

VI. FISH CONSERVATION

1. The protective dimension of the fish is the length of fish from the beginning of its head to the furthest end of its tail fin.

2. The following protective dimensions of fish apply:

- grass carp up to 40 cm
- asp up to 40 cm
- barbel up to 40 cm
- vimba up to 30 cm
- huchen up to 70 cm
- orfe up to 25 cm
- dace up to 15 cm
- carp up to 30 cm and upper from 70 cm
- Dębowa reservoir - upper limit of carp from 60 cm and of grass carp from 70 cm
- tench up to 25 cm
- perch up to 18 cm
- salmon up to 35 cm
- burbot up to 25 cm
- rainbow trout, spring trout, sparcctic trout up to 30 cm
- pike up to 50 cm and top from 90 cm
- zander up to 50 cm and upper from 90
- catfish up to 70 cm
- nase up to 25 cm
- eel up to 60 cm
- rudd up to 15 cm
- zope up to 25cm
- chub up to 25 cm

3. The following protection periods has been established:

- **asp** from 1 January to 30 April
- **barbel** from 1 January to 30 June

- **burbot** from 1 December to the end of February
- **eel** from 1 December to 31 March
- **pike** - on the dam reservoirs of Nysa, Otmuchów, Turawa, Brzózki, Michalice, Kluczbork and Ujazd from 1 January to 31 May, in other waters from 1 January to 30 April
- **zander** from 1 January to 31 May
- **catfish** from 1 January to 31 May
- **nase** from 1 January to 15 May
- **bull trout** from 1 October to 31 December

4. The following daily quantitative limits for fish to be taken from fisheries have been introduced (between 0:00 and 24:00)

- rainbow, spring, sparcctic trout (in total) 3 pcs.
- eel 2 pcs.
- carp 2 pcs.
- catfish (applies to the Odra River) 3 pcs.
- zander, pike (in total) 2 pcs.
- barbel 3 pcs.
- asp 2 pcs.
- tench 4 pcs.
- bream - 10 pcs, each of over 35 cm in length
- perch 10 pcs.
- grass carp 2 pcs.

The total quantity of fish caught and taken from the fisheries of the listed species may not exceed 10 fish per day.

The annual limit for pike and zander is a total of 35 pieces.

5. Fish of other species not mentioned above may be taken from the fishery in quantities not exceeding 5 kg per day.
6. Catch limits do not apply to silver carp, silver bream carp and silver crucian carp.

In addition, the following rules apply:

1. There is an absolute ban on taking grayling and stream trout from the waters of the Opole district.
2. On the dam reservoirs of Nysa, Otmuchów, Turawa, Michalice, Brzózki, Kluczbork and Ujazd from 1 January to 31 May, fishing by spinning and fly fishing is prohibited both from boats and from the shores. Fishing from boats is allowed from 1 May.
3. The prohibition of fishing using 'live' and 'dead fish' bait, as well as parts thereof, shall apply to dam reservoirs from 1 January to 31 May and to other waters from 1 January to 30 April.
4. The Kluczbork reservoir prohibits fishing using 'live' and 'dead fish' bait, as well as parts thereof.
5. The standing waters outside the fishing circuits after restocking with carp and rainbow, spring and sparcctic trout, assigned by the District, are subject to a two-week fishing ban. Closing waters after restocking by a local fishing club with the consent of the Chief Ichthyologist of the District of PZW Opole is also allowed. Exceptions are the "catch and release" waters.
6. On the Nysa Kłodzka from the Zb. Kozielno reservoir dam to the Nysa does not have a pain limit.
7. On the Nysa Kłodzka River, between the Nysa Reservoir dam and the weir at Aleja Wojska Polskiego, a ban on spinning and fly fishing is introduced between 01.01.2023 and 30.04.2023.
8. Salmonids can only be fished with the use of artificial lures, i.e. by spinning or fly fishing. Not applicable to rainbow trout, spring trout, sparcctic trout.
9. Fish caught (in accordance with the daily limit) must be kept within the fishing spot until the fishing is completed.
10. Anglers are obliged to leave the fishery during the fishing competition organised by the Branches and the District of PZW Opole (information on the website or in the area by the water).

11. The rules set by the Fishing Clubs and the District of PZW Opole and displayed on the information boards should be followed.
12. It is prohibited to: (a) swim (b) leave garbage and waste behind (c) use soap and other harmful chemicals.
13. It is prohibited to fish from boats at night (from dusk till dawn, from one hour before sunrise to one hour after sunset), with the exception of the period from 1 June to 31 October.
14. Anglers who have used their annual quantitative limits for zander and pike are not allowed to take more fish of these species from the fisheries.
15. In the event of loss of the permit for amateur fishing, a duplicate permit entitling to fish with the exception of fishing for pike and zander will be issued by the treasurer of the Branch, the full permit is issued only by the Management Board of the District of PZW Opole.
16. It is prohibited to fish from boats on reservoirs of up to and including 10 acres. This prohibition also applies to the removal of baits using boats and remotely controlled devices.
17. On the Ilak reservoir in Siestrzechowice, it is allowed to fish using the fly fishing method from a belly boat.
18. Fish subject to limits, not recorded in the catch log or obtained contrary to the permit are subject to be secured and confiscated by the authorised fishing control authorities (in accordance with Art. 23 points 4b of the Act on Inland Fishing); pursuant to Art. 27a section 2b of the Act, the competent authority may submit a case to the District Court.
19. It is forbidden to mark fishing places with bottles, containers, and other objects.
20. It is forbidden to fish from 1 July to 31 July in the Kluczbork reservoir.
21. Anglers are obliged to maintain cleanliness at a radius of 5 meters of their fishing spot, regardless of the initial state of cleanliness at this spot (applies to all methods of fishing).

Resolution No. 75 of the Main Board of the Polish Angling Association of 08-03-2015.

In the event of a violation of the provisions on amateur fishing by a person holding this permit, the issuer may withdraw it with a statement delivered to its holder. It is considered that a permit withdrawn in accordance with the decision of the fellow members is not valid for the period indicated in the decision. Consequently, the person using the withdrawn permit during its non-binding period is punishable by a penalty for the lack of a valid permit issued by the fishing authorisation holder.

As a reminder,

- **Any use of a lift net is allowed only during fishing with a fishing rod. (lift net with dimensions of 1 meter per 1 meter with a mesh of not less than 5 mm). Catching fish with a lift net is a crime.**

- Any observed contamination of the aquatic environment should be notified to **WIOŚ** (774539906 or 606605052) and the **Water Protection Department of the PZW Opole District Office** tel. 77/454-55-54, 604440595
- Anglers are obliged to maintain cleanliness at a radius of 5 meters of their fishing spot, regardless of the initial state of cleanliness at this spot.
- In the case of catching a marked fish and taking it from a fishery, an angler is obliged to provide the information about its species, length, weight and date and place of catching it to the District Board

(in the case of not taking the marked fish, the District Management Board should be informed about the catch).

- When catching fish from any watercraft, it is mandatory to remain sober.
- Each watercraft must be equipped with the obligatory rescue and safety equipment.
- It is forbidden to pass through the protective embankments.
- Information about agreements concluded with other Districts can be found on the website <http://www.pzw.org.pl/opole/> and at the headquarters of the Fishing Clubs.
- In accordance with resolutions of the District Board and regulations of the President of the PZW Opole District Office, some of the listed fisheries, sections of rivers, their tributaries, as well as standing waters may be permanently or periodically closed for fishing, e.g. after restocking, at low water levels, during fishing competitions, etc.
- In exceptional cases, the District Board may introduce additional restrictions and regulations by resolutions.

Regulations for catch and release fisheries

When fishing at the 'catch and release' fisheries, it is prohibited to:

- bring fish caught in other fisheries;
- fish from islands;
- use live or dead fish (or parts thereof) as bait;
- use combustion powered watercrafts (not applicable to authorities authorised to inspect);
- at the "catch and release" Biała Głucholaska and Ilak Siestrzechowice fisheries, only fly fishing is permitted and the rods must be equipped with barbless hooks.

It is obligatory to

- have a landing net;
- use barbless hooks in the waters of the land of trout and grayling
- release fish immediately after catching (does not apply to fishing competitions reported to the PZW District of Opole);
- it is recommended to use unhooking mats.

Using unhooking mats is recommended (obligatory in the waters marked in the above table in the "comments" column).

- 'Unhooking mat'- a mat or structure designed to safely take fish off the hook and thus protect them against injuries (abrasions, loss of mucus), made of materials with a smooth structure inert to the aquatic environment with a soft filling of at least 2 cm or mats without soft filling, inflatable or stretched on a rigid rack. Minimum size 80 cm x 45 cm.
- Spinycheek crayfish, signal crayfish and fish of the Chinese sleeper species , round goby, stone moroko and bullpout after catching must not be released into the fishery where they were

caught or into any other waters.

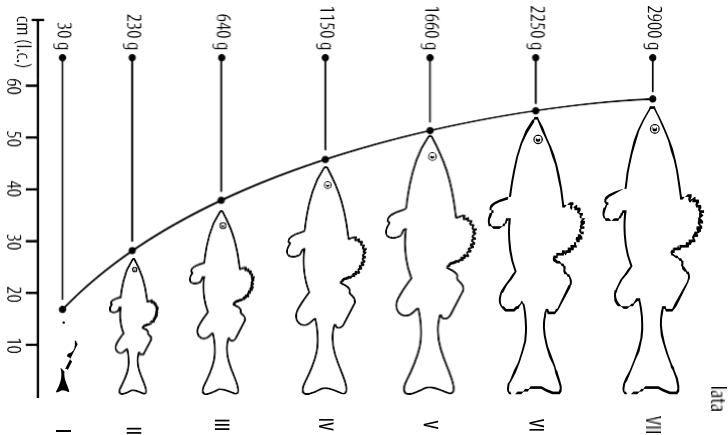
